A BILL FOR AN ACT

To further amend section 3 of Public Law No. 17-64, as amended by Public Laws Nos. 17-69 and 17-74, in order to appropriate \$70,000 in supplemental funding from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, to make a technical amendment, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

"Section 1. Purpose. The purpose of this act is to appropriate the sum of $\{44,786,854\}$ 44,856,854 or so much thereof as may be necessary, from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, for the purpose of funding the operations of all branches of the National Government of the Federated States of Micronesia, its agencies, various programs, grants, subsidies and contributions, and Capital and Human Resources Development. Of the total amount of funds appropriated herein, \$4,252,868 shall be deemed to come from funds available under the amended Compact from the education sector subject to the receipt of Grant Awards under the amended Compact; \$1,168,765 shall be deemed to come from funds available under the Supplemental Education Grant;
