A BILL FOR AN ACT

To further amend section 103 of title 36 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 15-75 and 16-47, to require a institutionalized financial report or document be submitted and specify documents that require notarization for major corporations, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Secti	on 1. Section 103 of title 36 of the Code of the

3	15-75 and	16-47, is hereby further amended to read as follows:
4		"Section 103. Application for charter - Articles of
5		Incorporation.
6		(1) An association of persons seeking a charter as
7		a corporation shall submit for approval of the
8		President of the Federated States of Micronesia, or
9		his designee, articles of incorporation which shall
10		provide at least the following information:
11		(a) proposed name of the corporation;
12		(b) principal office or place of business;
13		(c) proposed duration;
14		(d) purposes;
15		(e) powers;
16		(f) capitalization;
17		(g) names of incorporators, which shall be one
18		or more;

1	(h) number of directors, which shall be one or
2	more, and proposed officers;
3	(i) name(s) of director(s) and officers to
4	serve until first election;
5	(j) provisions of management, if any;
6	(k) provisions for voting by members;
7	(1) provisions for shareholding, if any;
8	(m) disposition of financial surplus;
9	(n) provisions for liquidation;
10	(o) provisions for amendment of articles of
11	incorporation.
12	(2) A major corporation as defined under chapter 3
13	of title 54 of the Code must submit an affidavit $\underline{\text{or}}$
14	institutionalized financial report or document to the
15	Office of the Registrar by the President and
16	Secretary of the corporation as named in the articles
17	of incorporation not later than sixty (60) days from
18	the date of receipt of the certificate of
19	incorporation.
20	(3) The affidavit referred to under subsection (2)
21	of this section, [and any other document that
22	requires notarization, articles of incorporation and
23	subsequent amendments, dissolution, liquidation and
24	merger documents shall be notarized by an authorized
25	FSM notary or a notary public accredited by the

Registrar of Corporations."
        Section 2. This act shall become law upon approval by the
