Congressional Act No. 17-05, "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 16-62, AS AMENDED BY PUBLIC LAW NO. 16-71, BY AMENDING SECTIONS 2, 4, 5 AND 6 THEREOF, TO CHANGE THE USE AND ALLOTTEE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATES OF POHNPEI, KOSRAE AND CHUUK, AND TO OFFER A TECHNICAL AMENDMENT THERETO, AND FOR OTHER PURPOSES."

I appreciate the immediate and appropriate actions taken by Congress to consider the concerns noted in connection with Public Law No. 16-62, which was the amendment prior to this act. While I do not oppose public projects and social programs, I am concern with the repeated changes in the use of public projects and social programs which in essence may be interpreted as an indecision or weakness on our part as government planners and decision makers. We must continue to ensure that the public projects and social programs are not politically motivated but rather are in line with the Nations development plan.

6	under subsection 5(3) of this act shall be the
7	Executive Director of the Northern Namoneas Social
8	and Economic Development Authority. The funds
9	appropriated by this act shall remain available until
10	fully expended."
11	Section 5. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its
13	becoming law without such approval.
