

**PUBLIC LAW No. 17-79**

AN ACT

To further amend section 672 of title 55 of the Code of the Federated States of Micronesia, as amended by Public Law No. 16-66, in order to allow expenditures for oil, provisions and spare parts for FSM patrol and surveillance boats to be charged against the Maritime Surveillance Revolving Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 672 of title 55 of the Code of the  
2 Federated States of Micronesia, as amended by Public Law No.  
3 16-66, is hereby further amended to read as follows:

4                   "Section 672. Purpose. The purpose of the Fund is to  
5                   provide reliable funding for fuel, oil, provisions, and  
6                   spare parts for the patrol and surveillance boats of the  
7                   National Government of the Federated States of  
8                   Micronesia. The Fund shall not be used for salaries or  
9                   overtime."

1       Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.


