PUBLIC LAW NO. 17-87

AN ACT

To further amend sections 4 and 6 of Public Law No. 17-36, as amended by Public Laws Nos. 17-48 and 17-78, to change the use and allottee of certain funds previously appropriated to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

All funds appropriated by this act shall be allotted, managed, administered and accounted for 5 in accordance with applicable laws, including, but 6 not limited to, the Financial Management Act of 1979. 7 The allottee shall be responsible for ensuring that 8 these funds, or so much thereof as may be necessary, 9 are used solely for the purpose specified in this 10 11 act, and that no obligations are incurred in excess 12 of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the 13 14 Governor of Yap State.
