## A BILL FOR AN ACT

To amend title 2 of the Code of the Federated States of Micronesia, by further amending section 203, as amended by Public Laws Nos. 10-55, 15-09 and 15-74, and by further amending section 204, as amended by Public Laws Nos. 10-55, 13-75 and 15-09, for the purpose of transferring the Budget Office to the Department of Finance and Administration and transferring the function of economic planning to the Department of Resources and Development, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 203 of title 2 of the Code of the 1 Section 1. Federated States of Micronesia, as amended by Public Laws Nos. 10-55, 15-09 and 15-74, is hereby further amended to read as follows: 5 "Section 203. Departments. (1) There shall be the following departments 6 7 which shall be responsible for major programs or administrative support areas in the Government 8 of the Federated States of Micronesia: 9 (a) Department of Resources and 10 11 Development; which shall include the function of 12 economic planning. 13 (b) Department of Finance and Administration, which shall include the Budget 14 Office; 15 (c) Department of Foreign Affairs; 16 (d) Department of Health and Social 17

3	(f) Department of Transportation, Communication
4	and Infrastructure, which shall contain among other
5	units, a Project Management Unit for the Compact
