A BILL FOR AN ACT

To further amend Public Law No. 17-68, as amended by Public Laws Nos. 17-71, 17-81, 17-84, 17-89, 17-90, 18-03, 18-10, 18-13, 18-32 and 18-46, by amending sections 4 and 6 therein, for the purpose of changing the use and allottee of certain funds previously appropriated to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 4 of Public Law No. 17-68, as amended by
 Public Laws Nos. 17-71, 17-84, 18-32 and 18-46, is hereby further
 amended to read as follows:

23	"Section 6. Allotment and management of funds	
24	and lapse date. All funds appropriated by this	
25	act shall be allotted, managed, administered and

1	accounted for in accordance with applicable
2	laws, including, but not limited to, the
3	Financial Management Act of 1979. The allottee
4	shall be responsible for ensuring that these
5	funds, or so much thereof as may be necessary,
6	are used solely for the purpose specified in
7	this act, and that no obligations are incurred
8	in excess of the sum appropriated. The allottee
9	of the funds appropriated under section 2 of
10	this act shall be the Governor of Yap State.
11	The allottee of funds appropriated under
12	sections 3 and 4 of this act shall be the
13	President of the Federated States of Micronesia
14	or his designee, EXCEPT THAT the allottee of
15	funds appropriated under subsection 1 of section
16	3 of this act shall be the Governor of Kosrae;
17	the allottee of funds appropriated under
18	subsections 3(2)(j), (k), (l), (m), (n),
19	(o),(p), (q), (r), (s), (t), (u), (v), (w), (x),
20	(y), (z), (aa), (ab), (ac), (ad), (ae), (af),
21	(ag) and (ah) of section 3 of this act shall be
22	the Mayor of Lelu Municipal Government or his
23	designee [and]; the allottee of funds
24	appropriated under subsection 1 of section 4 of
25	this act shall be the Governor of Pohnpei State

1	and the allottee of funds appropriated under
2	subsections 4(c)(xxiii) and 4(c)(xxiv) of
3	section 4 of this act shall be the Meninkeder
4	lapalap, Madolenihmw Municipal Government. The
5	allottee of funds appropriated under subsection
6	5(1) of this act shall be the President of the
7	Federated States of Micronesia or his designee.
8	The allottee of funds appropriated under
9	subsection $5(2)(a)$ and $5(2)(c)$ of this act shall
10	be the Governor of Chuuk State or his designee.
11	The allottee of funds appropriated under
12	subsection 5(2)(b) of section 5 of this act
13	shall be the Mortlock Islands Development
14	Authority. The allottee of funds appropriated
15	under subsection 5(2)(d) of section 5 of this
16	act shall be the Southern Namoneas Development
17	Authority or its designee. The allottee of
18	funds appropriated under subsection 5(2)(e) of
19	section 5 of this act shall be the Faichuk
20	Development Authority or its designee. The
21	allottee of funds appropriated under subsection
22	5(2)(f) of section 5 of this act shall be the
23	Northwest Island Development Authority. The
24	authority of the allottee to obligate funds
25	appropriated by this act shall lapse on

2	Section 3. This act shall become law upon approval
3	by the President of the Federated States of Micronesia or
4	upon its becoming law without such approval.
