A BILL FOR AN ACT

To appropriate a supplemental budget of \$20,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, by amending sections 1, and 3 of Public Law No. 18-15, as amended by Public Law No. 18-26 and 18-41, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 18-15, as amended by
 Public Laws Nos. 18-26 and 18-41, is hereby further amended to
 read as follows:

Of the 12 13 total amount of funds appropriated herein, \$2,400,000 14 shall be deemed to come from funds available under the Amended Compact from the education sector; \$-0- shall be 15 16 deemed to come from funds available under the Amended Compact from the health sector; \$-0- shall be deemed to 17 18 come from funds available under the Amended Compact from

1 the infrastructure sector; \$-0- shall be deemed to come from funds available under the Amended Compact from the 2 public sector capacity building; \$-0- shall be deemed to 3 come from funds available under the Amended Compact from 4 the enhanced reporting and accountability sector; and 5 \$1,112,158 shall be deemed to come from funds available 6 7 under the Supplemental Education Grant. The sum appropriated herein shall be apportioned as follows:" 8 Section 2. Section 3 of Public Law No. 18-15, as amended by 9 10 Public Laws Nos. 18-25 and 18-41, is hereby further amended to 11 read as follows: "Section 3.
