## A BILL FOR AN ACT

To appropriate a supplemental budget of \$210,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, by amending sections 1 and 3 and of Public Law No. 18-15, as amended by Public Laws Nos. 18-26, 18-41 and 18-54, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 18-15, as amended by
Public Laws Nos. 18-26, 18-41 and 18-54, is hereby further
amended to read as follows:

Title. The title of this act is as 5 "Section 1. follows: To appropriate the sum of \$[58,490,777] 6 7 58,700,771 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 8 2014, for the purpose of funding the operations of all 9 branches of the National Government of the Federated 10 States of Micronesia, its agencies, various programs, 11 12 grants, subsidies and contributions and Capital and Human Resources Development. Of the total amount of 13 14 funds appropriated herein, \$2,437,568 shall be deemed to 15 come from funds available under the Amended Compact from the education sector; \$-0- shall be deemed to come from 16 17 funds available under the Amended Compact from the health sector; \$-0- shall be deemed to come from funds 18 19 available under the Amended Compact from the

infrastructure sector; \$-0- shall be deemed to come from 1 2 funds available under the Amended Compact from the public sector capacity building; \$-0- shall be deemed to 3 come from funds available under the Amended Compact from 4 5 the enhanced reporting and accountability sector; and \$1,112,158 shall be deemed to come from funds available 6 7 under the Supplemental Education Grant. The sum appropriated herein shall be apportioned as follows:" 8 9 Section 2. Section 3 of Public Law No. 18-15, as amended by 10 Public Laws Nos. 18-26, 18-41 and 18-54, is hereby further 11 amended to read as follows:

12 "Section 3. Operating Expenses of the Legislative The sum of \$[4,020,228] 4,230,228 or so much 13 Branch. thereof as may be necessary, is hereby appropriated 14 from the General Fund of the Federated States of 15 Micronesia for the fiscal year ending September 30, 16 2014, for the operations of the Legislative Branch of 17 the National Government during fiscal year 2014.
