## A BILL FOR AN ACT

To appropriate \$260,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of supporting the efforts of the  $8^{\text{th}}$  Micronesian Games Organizing Committee, by amending Public Law No. 18-55, and for other purposes.

BE I	F ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Purpose. The sum of $\$[400,000]$ 660,000, or so
2	much thereof as may be necessary, is hereby appropriated from
3	the General Fund of the Federated States of Micronesia for the
4	fiscal year ending September 30, 2014, for the purpose of
5	providing funding for the athletes and coaches from the four
6	States to participate in the 2014 Micronesian Games and
7	international cultural festivals, and to support the efforts of
8	the 8 <sup>th</sup> Micronesian Games Organizing Committee. The funds shall
9	be apportioned as follows:
10	(1) State of Yap\$ 100,000
11	(2) State of Kosrae
12	(3) State of Pohnpei
13	(a) to provide funding for the athletes and
14	<u>coaches</u>
15	(b) to support the efforts of the 8 <sup>th</sup>
16	Micronesian Games Organizing Committee 260,000
17	(4) State of Chuuk
18	Section 2. Allotment and management of funds and lapse

date. All funds appropriated by this act shall be allotted, 2 managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial 3 Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be 5 necessary, are used solely for the purpose specified in this 7 act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under subsection 1(1) of this act shall be the Governor of the State of Yap or his designee. The allottee of funds appropriated 10 11 under subsection 1(2) of this act shall be the Governor of the 12 State of Kosrae or his designee. The allottee of funds appropriated under subsection 1(3)(a) of this act shall be the 13 14 Governor of the State of Pohnpei or his designee. The allottee 15 of funds appropriated under subsection (1)(3)(b) of this act shall be the President of the Federated States of Micronesia or 16 his designee. The allottee of funds appropriated under 17 subsection 1(4) of this act shall be the Governor of the State 18 of Chuuk or his designee. The authority of the allottee to 19 obligate funds appropriated by this act shall lapse on 20 21 September 30, 2014. 22 23 24
