## A BILL FOR AN ACT

To further amend section 104 of title 3 of the Code of the Federated States of Micronesia, as amended by Public Law No. 13-79, to add a Government Accountability Office to Congress, and creating a new chapter 8 concerning the rights, powers, and authority of the Government Accountability Office, and for other purposes.

BE 11T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 2 Section 1. Policy and Purpose. The purpose of this bill is
- 3 to create the Government Accountability Office (GAO), an
- 4 independent and nonpartisan agency, to work for Congress. The GAO
- 5 shall preform work at the request of Congress or Congressional
- 6 subcommittees or as mandated by public law or committee reports.
- 7 The GAO shall advise Congress about ways to make the government
- 8 more efficient, effective, ethical, equitable and responsive. The
- 9 GAO will by request, audit agency operations to ensure federal
- 10 funds are being spent effectively; investigate allegations of
- 11 illegal or improper activities; issue decisions and opinions;
- 12 preform policy analysis; report on government programs and
- 13 policies to determine if objectives are being met; and other
- 14 duties as directed by Congress to ensure that public funds are
- 15 being properly utilized. Congress has created the GAO for the
- 16 benefit of the citizenry of the Federated States of Micronesia to
- 17 ensure a greater economy and efficiency of federal funds.

11	Congress of the Federated States of Micronesia. The
12	Government Accountability Office shall have the authority
13	to subpoena in furtherance of its duties and
14	responsibilities by resolution from the Congress."
15	Section 6. This act shall become law upon approval by the
16	President of the Federated States of Micronesia or upon its
17	becoming law without such approval.
