## A BILL FOR AN ACT

To amend section 13 of Public Law No. 18-15, to extend the lapse date for appropriated funds in FY 14 for the PMU Operations under Section 2 (5), and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Policy and Purpose. The purpose of this bill is
- 2 to extend the lapse date to of funds available for the line item
- 3 in Section 2(5) for PMU Operations until the funds are expended,
- 4 or the grant expires or is terminated, whichever is earlier. The
- 5 PMU Operations were appropriated as a line item to Section 2 (5)
- 6 by Public Law 18-75, which amended Public Law 18-15. This was done
- 7 as a result of the PMU Operations receiving a grant. There are
- 8 currently unexpended funds available to the PMU operations out of
- 9 this grant, which require an extension.
- 10 Section 2. Section 13 of Public Law 18-15 is hereby amended to
- 11 read as follows:
- 12 "Section 13. Allotment and management of funds and
- lapse dates.
- 14 (1) General provisions.
- 15 (a) All funds appropriated by this act shall be
- 16 allotted, managed, administered and accounted for in
- 17 accordance with applicable law, including, but not
- limited to, the Financial Management Act of 1979.
- 19 (b) The allottees shall be responsible for

ensuring that these funds, or so much thereof as may be 1 2 necessary, are used solely for the purposes specified in this act, and that no obligations are incurred in excess 3 of the sums appropriated. 4 (2) Allottees. The allottees of the funds 5 appropriated by this act are as follows: 6 7 (a) Section 2 - the allottee of these funds shall be the President of the Federated States of Micronesia; 8 9 (b) Section 3 - the allottee of these funds shall 10 be the Speaker of the Congress of the Federated States of Micronesia: 11 12 (c) Section 4 - the allottee of these funds shall be 2the Chief Justice of the Supreme Court of the 13 Federated States of Micronesia; 14 (d) Section 5 - the allottee of these funds shall 15 be the Public Auditor of the Federated States of 16 Micronesia: 17 (e) Sections 6 through 9 - the allottee of these 18 funds shall be the President of the Federated States of 19 20 Micronesia; PROVIDED, HOWEVER, that for the following subsections of sections 8 through 9 of this act: 21 22 (i) Section 8(6)(g) - the allottee shall be 23 the President of the College of Micronesia - FSM; and (ii) Section 8, (13)(a) through (d) - the 24 allottee of these funds shall be the Chief Justice of 25

1 the respective State Supreme Court; 2 (iii) Section 8 (10)(a) through (d) - the 3 allottee of these funds shall be the Speaker of the Congress of the Federated States of Micronesia; and (iv) 4 Section 9(1)(a) through (c) - the allottee of these 5 funds shall be the President of the College of 6 7 Micronesia-FSM. (3) Lapse date. The authority of the allottees to 8 9 obligate funds appropriated by this act shall lapse as of September 30, 2014; PROVIDED, HOWEVER, that the funds 10 appropriated under section 9 of this act shall not 11 12 lapse; PROVIDED, FURTHERMORE, that the funds appropriated for the line item in Section 2 (5) for PMU 13 Operations shall not lapse until the funds are expended, 14 or the grant expires or is terminated, whichever is 15 16 earlier." Section 3.
