A BILL FOR AN ACT

To further amend section 112 of title 52 of the Code of the Federated States of Micronesia, as amended by Public Law Nos. 11-81 and 13-64, and by inserting a new section 208 to chapter 2 of title 52 F.S.M.C., to provide for a cost-of-living allowance (COLA) for all of the employees of the National Government of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 112 of title 52 of the Code of the
- 2 Federated States of Micronesia, as amended by Public Law Nos.
- 3 11-81 and 13-64, is hereby further amended to read as follows:
- 4 "Section 112. <u>Definitions.</u> In this chapter, unless
- 5 the context requires otherwise, the following
- 6 definitions shall apply:
- 7 (1) "Adjusted base salary" means the total of base
- 8 salary plus marketplace premium, foreign service
- 9 premium, professional premium, or cost-of-living
- 10 allowance (COLA). If an employee is not entitled to
- any of these premiums, his adjusted base salary means
- 12 his base salary.
- 13 (2) "Base Salary" means the specific rate of pay for
- 14 a given pay level and step as contained within the
- 15 base salary schedule established by law. "Base
- 16 Salary" does not include premiums under section 163 of
- this chapter, professional premiums, cost-of-living
- 18 allowance (COLA), differentials under section 164 of

this chapter, or transfer, travel per diem, or other similar allowances.

- (3) "Class" or "class of positions" means a group of positions sufficiently similar so that all can reasonably be identified by the same title, be filled by applying the same qualification standards, and be equitably compensated by the same salary level. A class may consist of only one position or of any greater number of positions.
- increase in base salary to compensate for loss of purchasing power due to inflation. The COLA increment is not subject to tax or social security contribution.

 Employees exempt from the cost-of-living adjustment includes all officials elected in national elections including members of the Congress of the Federated

 States of Micronesia, President and Vice President of the Federated States of Micronesia, all employees whom are appointed to a position that requires advise and consent under Chapter 2, Section 207(1) of the Code of the Federated States of Micronesia, employees who receive a professional premium, and employees who receive the foreign service premium.

 $[\frac{4}{5}]$ "Eligible list" means a list of persons who have been found qualified for appointment to a

1	position in a particular class. Such a list may be
2	either reemployment, promotional, or open-competitive.
3	[(5)] <u>(6)</u> "Eligible person" or " <i>eligible</i> " means a
4	person whose name is on an active eligible list.
5	[(6)] <u>(7)</u> "Employee" means a person holding a
6	position in the public service, whether permanently or
7	otherwise.
8	[(7)] <u>(8)</u> "Foreign service premium" means a premium
9	set forth under subsection 163(2) of this title [to be
10	paid in addition to base salary to employees who are
11	citizens of the Federated States of Micronesia
12	assigned to permanent duty stations outside the
13	Federated States of Micronesia].
14	$\left[\frac{(8)}{(9)}\right]$ "Government of Federated States of
15	Micronesia" includes the Legislative, the Executive,
16	and the Judicial Branches and the agencies of the
17	Government of Micronesia.
18	$\left[\frac{(9)}{(10)}\right]$ "Management official" or "management" means
19	a person authorized to make appointments or changes in
20	status of employees in the public services.
21	[(10)] <u>(11)</u> "Market place premium" means a premium as
22	set forth under subsection 163(1) of this title.
23	$\left[\frac{(11)}{(12)}\right]$ "Open-competitive examination" means an
24	examination for positions in a particular class,
25	admission to which is not limited to persons employed

in public service. 1 2 $[\frac{(12)}{(13)}]$ "Open-competitive list" means list of 3 persons who have been found qualified by opencompetitive examination for appointment to a position 4 in a particular class. 5 $[\frac{(13)}{(14)}]$ "Personnel officer" means the head of the 6 7 Office of Personnel of the Government of the Federated States of Micronesia. $\left[\frac{(14)}{(15)}\right]$ "Position" means a group of duties and 9 responsibilities assigned by competent authority to be 10 11 performed by one person, working full-time or part-12 time. A position may be either occupied or vacant. $\left[\frac{(15)}{(16)}\right]$ (16) "Position classification plan" means the 13 14 arrangement in a systematic order of the titles of all 15 classes existing in the public service, with a description of each class. 16 $[\frac{(16)}{(17)}]$ "Probation period" means a period of 17 probationary employment status of not less than six 18 months nor more than one year from the beginning of an 19 employee's service in a particular position or class 20 in the public service. 21 22 [\frac{(17)}](18) "Professional premium" means a premium as 23 set forth under subsection 163(3) of this title. $[\frac{(18)}{(19)}]$ (19) "Promotional examination" means an 24 25 examination for positions in a particular class,

admission to which is limited to regular employees in 1 2 the public service. "Promotional list" means a list of 3 $[\frac{(19)}{(20)}]$ persons who have been found qualified by a promotional 4 examination for appointment to a position in a 5 particular class. 6 7 $[\frac{(20)}{(21)}]$ (21) "Public service" means all offices and other positions in the Government of the Federated States of Micronesia not exempted by section 117 of 9 10 this chapter. 11 $[\frac{(21)}{(22)}]$ "Reemployment list" means a list of 12 persons who have been regular employees in the public service and who are entitled to have their names 13 14 certified for appointment to a position in the class 15 in which they last held permanent status, or in a related class in the same or a lower salary range for 16 17 which they meet the qualification requirements. $\left[\frac{(22)}{(23)}\right]$ (23) "Regular employee" or "permanent employee" 18 19 means an employee who has been appointed to a position in the public service who has successfully completed a 20 probation period." 21 22 Section 2. Title 52 of the Code of the Federated States of Micronesia, as amended, is hereby further amended by inserting a 23 new section 208 of chapter 2 to read as follows: 24 25 "Section 208. Cost-of-living allowance (COLA).

1	All employees of the National Government of the
2	Federated States of Micronesia (including contract and
3	exempt employees) shall receive a cost-of-living
4	allowance (COLA) in the amount of \$40.00 per 80 hour
5	pay period. This COLA shall be in effect from July 1,
6	2015 to December 31, 2017."
7	Section 3. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its
9	becoming law without such approval.
