## A BILL FOR AN ACT

To amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82 and 17-85, by amending sections 4 and 5 thereof, for the purpose of changing the use of certain funds previously appropriated to fund public projects and social programs in the States of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 4 of Public Law No. 16-49, as amended
