Dear Speaker Halbert:

I transmit the following Congressional Act, which became Public Law No. 18-100 due to Congressional override of my veto:

Congressional Act No. 18-97, entitled: "AN ACT TO FURTHER AMEND TITLE 55 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA, AS AMENDED, BY ENACTING A NEW CHAPTER 16 THEREOF, FOR THE PURPOSE OF ESTABLISHING THE POHNPEI STATE COMMISSION ON IMPROVEMENT OF PROJECTS, AND OTHER PURPOSES."

In my transmittal to Congress dated October 31, 2014, I explained to Congress my position on this issue. I do not wish to restate here the reasoning of my veto, however, by reading the committee report, it is clear that the rationale behind the veto was not fully understood.

Establishing a commission that implements the public projects from Congress circumvents the Executive as the implementer of public laws. Creating a commission that goes parallel with the Executive and performs some of the functions of the Executive constitutes an affront of the separation of powers enshrined in the constitution. The Supreme Court elaborated on the concept of separation of powers in the Udot case and came to a realization that even the CSCIP, which was used as model for a Pohnpei commission, was itself "suspect." Several years after the Udot court opinion was issued, Congress agreed to dissolve the CSCIP. But this public law attempts to resurrect a questionable procedure of implementing public projects.

In light of the above, the Executive will use the constitution as its guide to ensure that when implementing the laws of this nation, the necessary constitutional precepts are preserved.



PUBLIC LAW NO. 18-100

AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by creating a new chapter 16 thereof, for the purpose of establishing the Pohnpei State Commission on Improvement Projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Title 55 of the Code of the Federated States of
- 2 Micronesia, as amended, is hereby further amended by creating a
- 3 new chapter 16 entitled: "Pohnpei State Commission on Improvement
- 4 Projects."
- 5 Section 2. Title 55 of the Code of the Federated States of
- 6 Micronesia is hereby further amended by adding a new section 1601
- 7 to chapter 16 to read as follows:
- 8 "Section 1601. Commission created.
- 9 There is hereby created a Pohnpei State Commission on
- 10 Improvement Projects ('PSCIP'). The commission shall be
- 11 composed of the following: a representative from each of
- the election districts within the State of Pohnpei, or his
- designee, and the Budget Officer of the Pohnpei State
- 14 Government. A majority of the chief municipal executives
- of the election district shall select a person from within
- the district to represent the district on the PSCIP."
- 17 Section 3. Title 55 of the Code of the Federated States of
- 18 Micronesia is hereby further amended by adding a new section 1602 to
- 19 chapter 16 to read as follows:
- 20 "Section 1602. Commission Organization; Quorum; Interim

Manager.

- (1) The commission shall meet to organize itself and to select a chairman and a vice chairman. The presence of a majority of the representatives from the election districts shall be necessary to constitute a quorum. Meetings shall be conducted according to bylaws adopted by the members. The Pohnpei State Budget Officer will be a non-voting member.
- (2) Until such time as sufficient representatives have been selected to constitute a quorum to organize, the Governor of the State of Pohnpei is authorized to appoint an interim manager to carry out duties and responsibilities authorized under subsections (1) through (5) of section 803.
- (3) Members of the commission shall serve terms of four(4) years.
- (4) To stagger the replacement of commission members, of the first commission to organize and the first only, one election district member shall serve a two year term, one a three year term, and one a four year term. The commission members shall determine this by a fair, random method of selection.
- (5) Members may be removed by a majority vote of the chief municipal executives in their election district.

 Removal shall be based on misconduct. Replacement members

1	shall be elected from the same election district."	
2	Section 4. Title 55 of the Code of the Federated States of	
3	Micronesia is hereby further amended by adding a new section 1603 to	
4	chapter 16 to read as follows:	
5	"Section 1603. Commission - Authority.	
6	The commission shall have the authority to:	
7	(1) Obligate funds appropriated and allotted to the	
8	commission by the Congress for projects in Pohnpei;	
9	(2) Award and enter into contracts for projects, giving	
10	priority to bids by Micronesian citizens or corporations	
11	qualified and capable of performing fully and without delay	
12	such projects;	
13	(3) Assess damage to private property caused by	
14	projects and negotiate written settlements on amounts of	
15	compensation, such written settlements to be treated as	
16	obligations for the purposes of the Financial Management Act	
17	of 1979;	
18	(4) Establish priorities for the performance of	
19	projects, ensuring that each district is treated as equally	
20	as possible;	
21	(5) Submit all reports required by applicable law,	
22	including, but not limited to, the Financial Management Act	
23	of 1979; and	
24	(6) Appoint an executive director, who may carry out	
25	such duties of the commission as the commission deems

1	advisable; the commissio	n may authorize the executive
2	director to hire staff."	
3	Section 5. This act shall b	pecome law upon approval by the
4	President of the Federated States	of Micronesia or upon its becoming
5	law without such approval.
