AN ACT

To further amend Public Law No. 18-35, as amended by Public Laws Nos. 18-49, 18-61, 18-63 and 18-94, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 read as follows: 3 "Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be 4 allotted, managed, administered and accounted for in 5 accordance with applicable laws, including, but not 6 7 limited to, the Financial Management Act of 1979. allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 9 solely for the purpose specified in this act, and that 10 11 no obligations are incurred in excess of the sum 12 appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap 13 State provided that the allottee of funds appropriated 14 15 under section 2(e) shall be the President of COM-FSM. The allottee of funds appropriated under sections 3 and 16 4 of this act shall be the President of the Federated 17 States of Micronesia or his designee, EXCEPT THAT the 18 19 allottee of funds appropriated under subsections (3)(a), (b), (c), (d), (e), (f), (q), (h), (i), (j), (k), (l), 20 (m), (n), (o), (p), (q), (r), (s), (t), (u), (v), (w), 21 22 (x), (y) and (aq) of section 3 of this act shall be the 23 Mayor of Lelu Town Government; the allottee of funds appropriated under subsections 4(3)(a), 4(3)(b) and 24 25 4(3)(e) of section 4 of this act shall be the Pohnpei

The allottee of funds 4 appropriated under subsections 5(1) and 5(3) of this act 5 shall be the Governor of Chuuk State or his designee. 6 7 The allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands Development 8 9 Authority. The allottee of funds appropriated under subsection 5(4) of this act shall be the Southern 10 11 Namoneas Development Authority. The allottee of funds 12 appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The allottee of 13 14 funds appropriated under subsection 5(6) of this act 15 shall be the General Manager of the Northwest Island Development Authority.
