## A BILL FOR AN ACT

To further amend Public Law No. 18-05, as amended by Public Laws Nos. 18-07, 18-14 and 18-31, by amending sections 3, 4 and 6 thereof, for the purpose of changing the use and allottee of certain funds previously appropriated therein to fund public projects and social programs in the States of Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

7	Section 3. Section 6 of Public Law No. 18-05, as amended by
8	Public Law No. 18-07, is hereby further amended to read as
9	follows:
10	"Section 6. Allotment and management of funds and
11	lapse date. All funds appropriated by this act shall
12	be allotted, managed, administered and accounted for
13	in accordance with applicable laws, including, but
14	not limited to, the Financial Management Act of 1979.
15	The allottee shall be responsible for ensuring that
16	these funds, or so much thereof as may be necessary,
17	are used solely for the purpose specified in this
18	act, and that no obligations are incurred in excess
19	of the sum appropriated. The allottee of the funds
20	appropriated under section 3 of this act shall be the
21	Governor of Yap State. The allottee of funds
22	appropriated under sections 2 and 4 of this act shall
23	be the President of the Federated States of
24	Micronesia or his designee, EXCEPT THAT the allottee
25	of funds appropriated under subsection 4(3)(a) of

1	this act shall be the Pohnpei Transportation
2	Authority. The allottee of funds appropriated under
3	subsections 5(1) and 5(3) of this act shall be the
4	Governor of Chuuk State or his designee. The
5	allottee of funds appropriated under subsection 5(2)
6	of section 5 of this act shall be the Mortlock
7	Islands Development Authority. The allottee of funds
8	appropriated under subsection 5(4) of section 5 of
9	this act shall be the Southern Namoneas Development
10	Authority. The allottee of funds appropriated under
11	subsection 5(5) of section 5 of this act shall be the
12	Faichuk Development Authority. The allottee of funds
13	appropriated under subsection 5(6) of section 5 of
14	this act shall be the Northwest Island Development
15	Authority. The authority of the allottee to obligate
16	funds appropriated by this act shall lapse on
17	September 30, 2014."
