## A BILL FOR AN ACT

To appropriate the sum of \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, for the purpose of funding public projects and social programs in the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Purpose. The sum of \$1,400,000, or so much Section 1. thereof as may be necessary, is hereby appropriated from the 2 General Fund of the Federated States of Micronesia for the fiscal 3 4 year ending September 30, 2016, for the purpose funding public projects and social programs in the states of Yap, Kosrae, Pohnpei 5 The funds appropriated under this section shall be 6 and Chuuk. 7 apportioned as follows:

8 Section 2. Of the sum of \$1,400,000 appropriated by this 9 act, \$200,000 is apportioned for public projects and social 10 programs in the state of Yap.

6	funds appropriated under subsection 5(2) of this act shall be			
7	the Mortlock Islands Development Authority. The allottee of			
8	funds appropriated under subsection 5(4) of this act shall be			
9	the Southern Namoneas Development Authority. The allottee of			
10	funds appropriated under subsection 5(5) of this act shall be			
11	the Faichuk Development Authority. The authority of the			
12	allottee to obligate funds appropriated by this act shall lapse			
13	on September 30, 2018."			
14	Section 7. This act shall become law upon approval by the			
15	President of the Federated States of Micronesia or upon its			
16	becoming law without such approval.
