A BILL FOR AN ACT

To further amend Public Law No. 16-18, as amended by Public Laws Nos. 16-24, 16-32, 16-39, 16-45, 16-54, 16-67, 17-04, 17-14, 17-26, 17-39, 17-65, 18-27, 18-47 and 18-80, by amending section 2 thereof, to change the allottee and lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 2 of Public Law No. 16-18, as amended
- 2 by Public Laws Nos. 16-24, 17-14, 17-39, 18-27 and 18-80, is
- 3 hereby further amended to read as follows:

4	"Section 2. Allotment and management of funds and lapse
5	date. All funds appropriated by this act shall be
6	allotted, managed, administered and accounted for in
7	accordance with applicable laws, including, but not
8	limited to, the Financial Management Act of 1979. The
9	allottee shall be responsible for ensuring that these
10	funds, or so much thereof as may be necessary, are used
11	solely for the purpose specified in this act, and that
12	no obligations are incurred in excess of the sum
13	appropriated. The allottee of the funds appropriated
14	under subsections 1 and 2 of section 1 of this act shall
15	be the President of the Federated States of Micronesia
16	or his designee, EXCEPT THAT the allottee of funds
17	appropriated under subsections 2(a), (b), (c), (d), (e),
18	(f), (g) , (j) , $(n(i))$, (p) , (q) and (r) of this act

shall be the Mayor of Lelu Municipal Government; the 1 2 allottee of funds appropriated under sections 1(4)(a) 3 [and], 1(4)(c) and 1(4)(f) shall be the Governor of 4 Chuuk State or his designee; the allottee of funds 5 appropriated under section 1(4)(b) shall be the Mortlock Islands Development Authority; the allottee of funds 6 7 appropriated under section 1(4)(d) shall be the Faichuk Development Authority; the allottee of funds 8 9 appropriated under section 1(4)(e) shall be the Souhtern Namoneas Development Authority; [and the allottee of 10 11 funds appropriated under section 1(4)(f) shall be the Northwest Island Development Authority]. 12 The allottee 13 of funds appropriated under section 1(1) of this act 14 shall be the Governor of the State of Yap. authority of the allottee to obligate funds appropriated 15 16 by this act shall lapse on September 30, [2015] 2016." Section 2.
