A BILL FOR AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59 and 18-86, by amending section 6 thereof, for the purpose of changing the allottee and lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 16-49, as amended
- 2 by Public Laws Nos. 17-10, 17-45, 17-85, 18-28 and 18-86, is
- 3 further hereby amended to read as follows:
- 4 "Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 7 accordance with applicable law, including, but not 8 limited to, the Financial Management Act of 1979. 9 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 10 11 solely for the purpose specified in this act, and that no 12 obligations are incurred in excess of the sum The allottee of funds appropriated under 13 appropriated. sections 2 and 4 of this act shall be the President of 14 the Federated States of Micronesia or his designee; 15 16 PROVIDED THAT the allottee of funds appropriated under section 4(1)(b) shall be the Pohnpei Transportation 17

Authority and the allottee of the funds appropriated 1 2 under section 4(1)(j) shall be the Mayor of Kolonia Town 3 Government. The allottee of funds appropriated under 4 section 3 of this act shall be the Governor of Yap State. 5 The allottee of funds appropriated under subsections 5(1), 5(3) [and], 5(6) and 5(7) of this act shall be the 6 7 Governor of Chuuk State or his designee. The allottee of 8 funds appropriated under subsection 5(2) of this act 9 shall be the Mortlock Islands Development Authority 10 (MIDA). The allottee of funds appropriated under 11 subsection 5(4) of this act shall be the Southern Namoneas Development Authority. The allottee of funds 12 13 appropriated under subsection 5(5) of this act shall be 14 the Faichuk Development Authority. [The allottee of 15 funds appropriated under subsection 5(6) of this act 16 shall be the Northwest Development Authority. The funds 17 appropriated by this act shall lapse on September 30, 18 [2015] 2016." 19 20 21 22 23
