Allotment and management of funds and lapse date. All funds appropriated by this act shall be 13 14 allotted, managed, administered and accounted for in accordance with applicable laws, including, but not 15 limited to, the Financial Management Act of 1979. 16 17 allottee shall be responsible for ensuring that these 18 funds, or so much thereof as may be necessary, are used 19 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 20 21 appropriated. The allottee of the funds appropriated 22 under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds 23 24 appropriated under section 3 shall be the President or 25 his designee, EXCEPT THAT the allottee of funds

1 appropriated under section 3(a), (b), (c), (d), (e), 2 (f), (g), (h), (i), (j), (k), (1), (m), (n), (o) and (u)shall be the Mayor of Lelu Town Government. The 3 allottee of funds appropriated under section 4 of this 4 5 act shall be the President or his designee, EXCEPT that 6 the allottee of funds appropriated under section 4(1)(a) 7 shall be the Secretary of the Department of Education; the allottee of funds appropriated under sections 8 9 4(1)(c), 4(1)(e), [and] 4(1)(h) and 4(2) shall be 10 Secretary of the Department of Transportation, Communications and Infrastructure; the allottee of funds 11 12 appropriated under section 4(1)(d) shall be the Pohnpei Port Authority; the allottee of funds appropriated under 13 14 section 4(1)(f) shall be the Nett District Government; the allottee of funds appropriated under section 4(1)(g) 15 shall be the Secretary of the Department of Resources 16 17 and Development; [the allottee of funds appropriated under section 4(2)(b) shall be the Mayor of Kapinga 18 Municipal Government]; the allottee of funds 19 20 appropriated under sections 4(3)(b) and 4(4)(a) shall be 21 the Pohnpei Transportation Authority and the allottee of 22 funds appropriated under section 4(3)(q) shall be the COM-FSM Cooperative Extension Service. The allottee of 23 24 funds appropriated under sections 5(1), 5(3) and 5(6) of this act shall be the Governor of Chuuk State or his 25

2	subsection 5(2) of this act shall be the Mortlock
3	Islands Development Authority. The allottee of funds
4	appropriated under subsection 5(4) of this act shall be
5	the Southern Namoneas Development Authority. The

7	this act shall be the Faichuk Development Authority.
8	The authority of the allottee to obligate funds
9	appropriated by this act shall lapse on September 30,
10	2016."
11	Section 3. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its
13	becoming law without such approval.
