## A BILL FOR AN ACT

Establishing a civil liability revolving fund by creating new subchapter XVI under chapter 6 of title 55 of the Code of the Federated States of Micronesia (Annotated), as amended, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Title 55 of the Code of the Federated States of
Micronesia (Annotated), as amended, is hereby further amended by
inserting under chapter 6 a new subchapter XVI entitled: "<u>Civil</u>
Liability Revolving Fund."

5 Section 2. Title 55 of the Code of the Federated States of 6 Micronesia (Annotated), as amended, is hereby further amended by 7 inserting under subchapter XVI of chapter 6 a new section 1630, to 8 read as follows:

9	"Section 1630. There shall be established a revolving
10	fund called the 'Civil Liability Revolving Fund.' The
11	deposits in the revolving fund do not lapse, provided,
12	however, that by end of the fiscal year, any amount
13	remaining in the revolving fund in excess of \$200,000
14	shall automatically be deposited in the general fund of
15	the Federated States of Micronesia."
16	Section 3. Title 55 of the Code of the Federated States of

17 Micronesia (Annotated), as amended, is hereby further amended by 18 inserting under subchapter XVI of chapter 6 a new section 1631, to 1 read as follows:

2		"Section 1631. The revolving fund shall be used for
3		payment of money judgment against the national
4		government or settlement of civil action against the
5		National Government."
6	Secti	on 4. Title 55 of the Code of the Federated States of
7	Micronesia	(Annotated), as amended, is hereby further amended by
8	inserting	under subchapter XVI of chapter 6 a new section 1632, to
9	read as fo	ollows:
10		"Section 1632. The Secretary of Justice shall render to
11		the President annual report on the status of the
12		revolving fund by August 30."
13	Secti	on 5. Title 55 of the Code of the Federated States of
14	Micronesia	(Annotated), as amended, is hereby further amended by
15	inserting	under subchapter XVI of chapter 6 a new section 1633, to
16	read as fo	ollows:
17		"Section 1633. The revolving fund shall hold
18		congressional appropriation to this revolving fund and
19		civil penalty derived from civil action by the national
20		government except for penalties from civil action under
21		title 24 of the Code."
