

# PUBLIC LAW No. 1 9- 15.

#### AN ACT

To further amend Public Law No. 18-42, as amended by Public Law No. 18-56, by amending section 2 thereof, to change the lapse date of certain funds previously appropriated therein, to fund the airport terminal facilities improvement and the upgrade of equipment of the Aircraft Rescue and Fire Fighting (ARFF) buildings in the States of Kosrae, Chuuk, Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 18-42 is hereby

"Section 2. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess The allottee of the funds of the sum appropriated. appropriated under this act shall be the respective Governor of each of the States; EXCEPT THAT, the allottee for Pohnpei State's share of Airport funds shall be the Pohnpei Port Authority and the allottee of Kosrae State's share of fund shall be the Kosrae

## PUBLIC LAW No. 1 9- 15

1	Port Authority. The authority of the allottee to
2	obligate funds appropriated by this act shall lapse
3	on September 30, 2016."
4	Section 2. This act shall become law upon approval by the
