

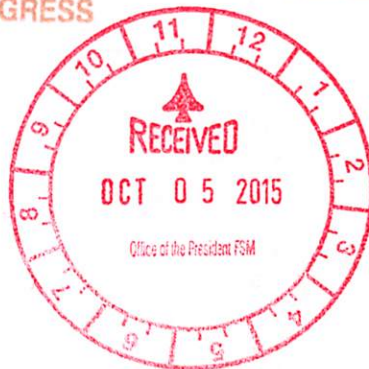

AN ACT


