CONGRESSIONAL BILL NO. 19-121

PHBLIC LAW No. 19-97

AN ACT

To amend section 203 of title 7 of the Code of the Federated States of Micronesia (Annotated), to provide that as matter of evidence the renewal of FSM passports constitutes a rebuttable presumption of renunciation of dual citizenship, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Purpose. The Congress recognizes and supports
- 2 the prohibition on dual citizenship in the FSM. Nevertheless
- 3 the Congress finds that it is often burdensome for citizens to
- 4 show evidence that they have relinquished the foreign
- 5 citizenship. This becomes acute in the case of FSM passport
- 6 renewal where at each renewal the citizen is once again asked
- 7 to present evidence of renunciation of foreign citizenship.
- 8 This bill will create a rebuttable presumption that citizens
- 9 whose FSM passport has been renewed twice shall be considered
- 10 to have relinquished the foreign citizenship and are solely FSM
- 11 citizens. The presumption is subject to rebuttal by the
- 12 Government.
- 13 Section 2. Section 203 of title 7 of the Code of the
- 14 Federated States of Micronesia (Annotated), is hereby amended
- 15 to read as follows:
- 16 "Section 203. A citizen of the Federated States of
- 17 Micronesia who is recognized as a citizen of another
- national shall, within three years of his eighteenth

1	birthday, or within three years of the effective date
2	of the Constitution, which ever is later, register
3	his intent to remain a citizen of the Federated
4	States of Micronesia with the President or his
5	designee in a manner and form prescribed by law or
6	regulation and renounce his citizenship of another
7	nation. If he fails to comply with this section, he
8	becomes a national of the Federated States of
9	Micronesia. A citizen who holds an FSM passport that
10	has been renewed twice in a row is entitled to a
11	rebuttable presumption that he has renounced the
12	citizenship of another nation and that he is solely
13	an FSM citizen."
