CONGRESSIONAL BILL NO. 19-176

AN ACT

To further amend title 40 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Law No. 19-90, by creating a new section 397, to provide for a transition period until the initial National Scholarship Board members are confirmed and the Board is functional, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Title 40 of the Code of the Federated States of 1 2 Micronesia (Annotated), as amended by Public Law No. 19-90, is 3 hereby further amended by adding a new section 397, to read as 4 follows: "Section 397. Transition period. 5 The Executive Branch may continue to review, award and 6 conduct business regarding national scholarships until 7 the initial National Scholarship Board members are 8 confirmed and the Board is functional, or until 9 November 30, 2016, whichever occurs first." 10 11 12 13 14 15 16 17 18
