PUBLIC LAW No. 1 9- 98

AN ACT

To further amend Public Law No. 17-68, as amended by Public Laws Nos. 17-71, 17-81, 17-84, 17-89, 17-90, 18-03, 18-10, 18-13, 18-32, 18-46, 18-58, 18-87, 18-95, 19-16 and 19-47, by amending sections 4 and 6 therein, for the purpose of changing the use and lapse date of certain funds previously appropriated to fund public projects and social programs for Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 4 of Public Law No. 17-68, as amended
2	by Public Laws Nos. 17-71, 17-84, 18-32, 18-46, 18-58, 18-95 and

Authority. The authority of the allottee to obligate
funds appropriated by this act shall lapse on September
30, 2017."
