CONGRESSIONAL BILL NO. 19-208, C.D.1

PUBLIC LAW No. 1 9- 107

AN ACT

To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121, 19-05, 19-34, 19-57 and 19-74, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 18-99, as amended by
- 2 Public Laws Nos. 18-113, 18-121, 19-05 and 19-34, is hereby further
- 3 amended to read as follows:

"Section 6. Allotment and management of funds and lapse 4 date. All funds appropriated by this act shall be 5 allotted, managed, administered and accounted for in 6 accordance with applicable laws, including, but not 7 limited to, the Financial Management Act of 1979. 8 allottee shall be responsible for ensuring that these 9 funds, or so much thereof as may be necessary, are used 10 solely for the purpose specified in this act, and that 11 no obligations are incurred in excess of the sum 12 The allottee of the funds appropriated 13 appropriated. under section 2 of this act shall be the Governor of Yap 14 State or his designee. The allottee of funds 15 appropriated under section 3 shall be the President or 16 his designee, EXCEPT THAT the allottee of funds 17

appropriated under section 3(a), (b), (c), (d), (e), (f), (g), (h), (i), (j), (k), (l), (m), (n), (o) and (u)shall be the Mayor of Lelu Town Government. allottee of funds appropriated under section 4 of this act shall be the President or his designee, EXCEPT that the allottee of funds appropriated under section 4(1)(a) shall be the Secretary of the Department of Education; the allottee of funds appropriated under sections 4(1)(c), 4(1)(e), 4(1)(h) and 4(2) shall be Secretary of the Department of Transportation, Communications and Infrastructure; the allottee of funds appropriated under section 4(1)(d) shall be the Pohnpei Port Authority; the allottee of funds appropriated under section 4(1)(f) shall be the Nett District Government; the allottee of funds appropriated under section 4(1)(g) shall be the Secretary of the Department of Resources and Development; the allottee of funds appropriated under sections 4(3)(b) and 4(4)(a) shall be the Pohnpei Transportation Authority and the allottee of funds appropriated under section 4(3)(g) shall be the COM-FSM Cooperative Extension Service. The allottee of funds appropriated under sections 5(1), 5(3) and 5(6) of this act shall be the Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock
