

PUBLIC LAW No. 19-116

AN ACT

To amend Public Law No. 19-65, to allow for funds previously appropriated for the Chuuk airport terminal pushcarts to be made available for other programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Purpose. The purpose of this bill is to amend  
2 Public Law 19-65 to allow for funds previously appropriated for  
3 the Chuuk airport terminal pushcarts to be made available for  
4 other programs.

5       Section 2. Section 2 of Public Law 19-65 is hereby amended  
6 to read as follows:

7       "Section 2. Chuuk State Priority Infrastructure Projects,  
8 including land acquisition and heavy equipment purchase to  
9 be apportioned as follows:..... \$   866,000  
10           (a) Monitoring and Administration costs ..       46,000  
11           (b) Heavy equipment purchase .....       260,000  
12           (c) Chuuk airport back-up generator .....       160,000  
13           (d) Chuuk airport urgent program needs....       50,000  
14           (e) Chuuk house renovation .....       350,000"

PUBLIC LAW No. 19- 116

1       Section 3. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
