allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum The allottee of the funds appropriated appropriated. under section 2 of this act shall be the Governor of Yap State. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3(a), (b), (c), (d), (e), (f), (g), (h), (t), (u), (v), (ag), (ar) and (as) of this act shall be the Mayor of Lelu Town Government or his designee; the allottee of funds appropriated under subsections 3(w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae), (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao), (ap) and (aq) of this act shall be the Mayor of Tafunsak Municipal Government or his designee; he allottee of funds appropriate under subsections ((1)(a), (b), (c), (e), (f), and 4(2) shall be the Secretary of the Department of Transportation, Communications and Infrastructure or his designee; he allottee of funds appropriated under subsections 4(1)(d), 4(3)(b), 4(3)(d), 4(3)(e) and 4(3)(1) shall be the Pohnpei Transportation Authority The sllottee of funds appropriated under (PTA).
