AN ACT

To further amend Public Law No. 17-68, as amended by Public Laws Nos. 17-71, 17-81, 17-84, 17-89, 17-90, 18-03, 18-10, 18-13, 18-32, 18-46, 18-58, 18-87, 18-95, 19-16, 19-47 and 19-98, by amending section 4 therein, for the purpose of changing the use of certain funds previously appropriated thereof, to fund public projects and social programs for Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 4 of Public Law No. 17-68, as amended
2 by Public Laws Nos. 17-71, 17-84, 18-32, 18-46, 18-58, 18-95,
3 19-47 and 19-98, is hereby further amended to read as follows:


