
Dear Speaker Simina:

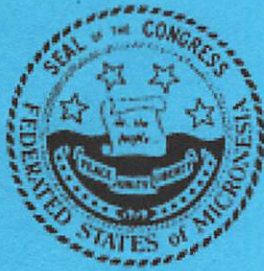

CONGRESSIONAL BILL NO. 19-277, C.D.1

AN ACT

To further amend Public Law No. 15-80, as amended by Public Laws Nos. 16-04, 17-53, 18-37, 18-66, 19-14 and 19-105, by amending sections 1 and 2 thereof, for the purpose of changing the use and allottee of certain funds previously appropriated therein, for public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-80, as amended
2 by Public Laws Nos. 16-04, 17-53, 18-37 and 18-66, is hereby
3 further amended to read as follows:

4 "Section 1. The sum of \$540,000 is hereby
5 appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending
7 September 30, 2009, for the purpose of funding the T-
8 3 Program Operation, public projects and social
9 programs in the States of Chuuk, Yap, Pohnpei and
10 Kosrae, and for other purposes. The sum appropriated
11 herein shall be apportioned as follows:

7 Section 2. Section 2 of Public Law No. 15-80, as amended
8 by Public Laws Nos. 16-04, 18-37, 18-66 and 19-14 and 19-105,
9 is hereby further amended to read as follows:

10 "Section 2. Allotment and management of funds and
11 lapse date.

12 (1) General Provisions.

13 (a) All funds appropriated by this act shall
14 be allotted, managed, administered and accounted for
15 in accordance with applicable law, including, but not
16 limited to, the Financial Management Act of 1979.

17 (b) The allottees shall be responsible for
18 ensuring that these funds, or so much thereof as may
19 be necessary, are used solely for the purpose
20 specified in this act, and that no obligations are
21 incurred in excess of the sum appropriated.

22 (2) Allottees. The allottees of the funds
23 appropriated by this act are as follows:

24 (a) Subsection 1 of Section 1 - the allottee
25 of these funds shall be the President of the

1 Federated States of Micronesia or his designee;
2 PROVIDED THAT the allottee of funds appropriated
3 under Subsection 1(c)(ii) of Section 1 shall be the
4 Mayor of Tafunsak Municipal Government or his
5 designee;

6 (b) Subsection 2 of Section 1 - the allottee
7 of these funds shall be the Governor of Yap State or
8 his designee, PROVIDED THAT the allottee of funds
9 under subsections (2)(c)(i) and (2)(c)(ii) of this
10 Act shall be the President of the College of
11 Micronesia - FSM;

12 (c) Subsection 3 of Section 1 - the allottee
13 of these funds shall be the President of the
14 Federated States of Micronesia or his designee;

15 (d) Subsection 4(a), 4(c) and 4(f) of Section
16 1 shall be the Governor of Chuuk State or his
17 designee; Subsection 4(b) of Section 1 shall be the
18 Mortlock Islands Development Authority; Subsection
19 4(d) of Section 1 shall be the Southern Namoneas
20 Development Authority; Subsection 4(e) of Section 1
21 shall be the Faichuk Development Authority;

22 (e) Subsection 5 of Section 1 - the allottee
23 of these funds shall be the President of the
24 Federated States of Micronesia or his designee.

25 (3) Lapse Date. The authority of the allottee to

1 obligate funds appropriated by this act shall lapse
2 on September 30, 2018."

3 Section 3. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.


