PUBLIC LAW No. 19-11

AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59 and 18-86, by amending sections 4 and 6 thereof, for the use purpose of changing the use, allottee and lapse date of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 16-49, as amended by
2 Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-82 and 18-59, is
3 hereby further amended to read as follows:

4 "Section 4. Of the sum of \$2,215,000 appropriated by
5 this act, \$610,000 is apportioned for Pohnpei State for

21 Section 6 of Public Law No. 16-49, as amended by Public
22 Laws Nos. 17-10, 17-45, 17-85, 18-28 and 18-86, is further
23 hereby amended to read as follows:

24 "Section 6. Allotment and management of funds and lapse
25 date. All funds appropriated by this act shall be

1 allotted, managed, administered and accounted for in
2 accordance with applicable law, including, but not
3 limited to, the Financial Management Act of 1979. The
4 allottee shall be responsible for ensuring that these
5 funds, or so much thereof as may be necessary, are used
6 solely for the purpose specified in this act, and that no
7 obligations are incurred in excess of the sum
8 appropriated. The allottee of funds appropriated under
9 sections 2 and 4 of this act shall be the President of
10 the Federated States of Micronesia or his designee;
11 PROVIDED THAT the allottee of funds appropriated under
12 section 4(1)(b) shall be the Pohnpei Transportation
13 Authority and the allottee of the funds appropriated
14 under section 4(1)(j) shall be the Mayor of Kolonia Town
15 Government. The allottee of funds appropriated under
16 section 3 of this act shall be the Governor of Yap State.
17 The allottee of funds appropriated under subsections
18 5(1), 5(3), 5(6) and 5(7) of this act shall be the
19 Governor of Chuuk State or his designee. The allottee of
20 funds appropriated under subsection 5(2) of this act
21 shall be the Mortlock Islands Development Authority
22 (MIDA). The allottee of funds appropriated under
23 subsection 5(4) of this act shall be the Southern
24 Namoneas Development Authority. The allottee of funds
25 appropriated under subsection 5(5) of this act shall be

1 the Faichuk Development Authority. The funds
2 appropriated by this act shall lapse on September 30,
3 2016."

4 Section 2. This act shall become law upon approval by the
5 President of the Federated States of Micronesia or upon its
6 becoming law without such approval.


