## AN ACT

To further amend Public Law No. 19-54, as amended by Public Law No. 19-62, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

this act shall be the Governor of Chuuk State or his
designee. The allottee of funds appropriated under
subsection 5(2) of this act shall be the Mortlock
Islands Development Authority. The allottee of funds
appropriated under subsection 5(4) of this act shall
be the Southern Namoneas Development Authority except
for subsection 5(4)(e) for which the allottee shall
be the Governor of Chuuk. The allottee of funds
appropriated under subsection 5(5) of this act shall
be the Faichuk Development Authority. The authority
of the allottee to obligate funds appropriated by
this act shall lapse on September 30, 2017."
