Since the outbreak of the Zika virus our Nation has been fortunate enough to receive funding to fight the further spread of this disease, and now to provide services to families with infants suffering from defeats caused by this disease.

Funding under this grant all goes down to the state level. Examples of uses of the funding include purchase of new ultrasound machines and training for their use, and the tele-medicine consulting program. A summary of the current proposed uses and budget are attached with this report. The Department stated that there is some flexibility to target areas, such as Kosrae, that are most impacted.
