- 1 WHEREAS, on September 4, 2015, several countries in the
- 2 Pacific region, including the Federated States of Micronesia,
- 3 signed a charter establishing the Pacific Island Development Forum
- 4 (the "Forum") as an international organization; and
- 5 WHEREAS, in establishing the Forum, the parties expressed
- 6 their mutual desire to promote peace, stability and development in
- 7 the Pacific through adherence to the principles of the United
- 8 Nations Charter; and
- 9 WHERREAS, the parties acknowledged the distinctiveness of
- 10 Pacific priorities in the face of the challenges posed by climate
- 11 change, globalization, and development; and
- 12 WHEREAS, the parties are convinced that these challenges
- 13 provide opportunities for all the sectors of society to work
- 14 together and cooperate in order to be able to address common
- 15 issues of climate change, sustainable development, and poverty
- 16 eradication in a manner that will improve the lives and livelihood
- 17 of citizens of Pacific island nations; and
- 18 WHEREAS, the parties commit to ensuring that no one should be
- 19 left behind in securing the benefits of development that is
- 20 inclusive of people with disabilities, gender, ethnicity, and the
- 21 elderly; and
