## AN ACT

To amend Section 16 of Public Law No. 1-37 relating to appropriations for the operating and contingent expenses of the Federated States Development Bank for Fiscal Years 1979 and 1980, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 16 of Public Law No. 1-37 is hereby amended to 2 read as follows:
- 3 "Section 16. The following appropriations are made subject
  4 to reporting requirements contained herein:

- (1) The sum of \$10,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Congress of the Federated States of Micronesia for the purpose of defraying the operating and contingent expenses of the Federated States Development Bank for Fiscal Year 1979.
- (2) The sum of \$40,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Congress of the Federated States of Micronesia, or its successor, for the purpose of defraying the operating and contingent expenses of the Federated States Development Bank for Fiscal Years 1980 and 1981.
- (3) The sum appropriated by Subsections (1) and (2) of this section shall be allotted by the Director of the Bureau of Finance, Department of Administrative Services, Trust Territory Government, or the Federated States of Micronesia Director of Finance to the President of the Federated States of Micronesia, or his designee, who shall be responsible for ensuring that these funds are used for the purposes specified

12	Micronesia before October 15, 1979, on expenditures of appro-
13	priations for Fiscal Year 1979, before September 30, 1980, on
14	expenditures of funds in Fiscal Year 1980, and before
15	September 30, 1981, on expenditures of funds in Fiscal Year
16	1981. Each report shall provide for the full accounting by

19	Section 2. This act shall become law upon approval by the President
20	or upon its becoming law without such approval.
