1	Section 1. The sum of \$415,900 or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the Federated
3	States of Micronesia for the fiscal year ending September 30, 1981, for
4	the purpose of funding certain public projects in the State of Ponape.

17	Section 3. This act shall become law upon approval by the President
18	of the Federated States of Micronesia, or upon its becoming law without
19	such approval.
