COMGRESSIONAL BILL NO. 1-85, C.D. 1

## AN ACT

To appropriate the sum of \$42,700 from the General Fund of the Congress of the Federated States of Micronesia for the fiscal year ending September 30, 1980, for the purpose of providing 20 percent matching funds for vocational rehabilitation programs within the States of the Federated States of Micronesia, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$42,700, or so much thereof as may be necessary,
2	is hereby appropriated from the General Fund of the Congress of the Federated
3	States of Micronesia for the fiscal year ending September 30, 1980, for the
4	purpose of providing 20 percent matching funds for vocational rehabilitation
5	programs within the States of the Federated States of Micronesia. The sum
6	appropriated by this section shall be apportioned in the following manner:
7	(1) State of Yap
8	(2) State of Truk
9	(3) State of Ponape
10	(4) State of Kosrae
11	Section 2. The sum appropriated by this act shall be allotted by the
12	Director of Finance to the President of the Federated States of Micronesia
13	who shall be responsible for ensuring that these funds are used only for the
14	purpose(s) specified in this act, and that no obligations are incurred in
15	excess of the sum appropriated. Any part of this appropriation not obligated
16	as of September 30, 1980 shall revert to the General Fund of the Congress of
17	the Federated States of Micronesia, or its successor.
18	Section 3. The President shall submit a detailed report to the Congress
19	of the Federated States of Micronesia before May 1, 1980 which shall:
20	(1) provide for the full accounting by object class of the
