CONGRESSIONAL RESOLUTION NO. 1-40

A RESOLUTION

Relating to fair State representation on the Board of Directors and the Credit Committee of the Federated States Development Bank.

- 1 WHEREAS, Chapter 3 of Title 29 of the Trust Territory Code creates
- 2 the Federated States Development Bank; and
- 3 WHEREAS, the Board of Directors of the Bank is composed of four
- 4 members appointed by the President of the Federated States of Micronesia,
- 5 with the advice and consent of this Congress, two members appointed by the
- 6 High Commissioner, and the Executive Director of the Trust Territory
- 7 Economic Development Loan Fund; and
- 8 WHEREAS, the national government of the Federated States of Micronesia
- 9 has drafted a revised Plan pursuant to the requirements of United States
- 10 Public Law 92-257 to provide for administration of the Economic Development
- 11 Loan Fund by the Federated States Development Bank; and
- 12 WHEREAS, the revised Plan provides for a Loan Credit Committee within
- 13 the Bank of five members, two selected by the High Commissioner, two selected
- 14 by the Chairman of the Board of Directors of the Bank, and one selected by
- 15 these four members; and
- 16 WHEREAS, the State-National Leaders Conference of the Federated States
- 17 of Micronesia, held in the State of Ponape on September 25 to 27, 1979,
- 18 resolved by consensus "that the High Commissioner and President of the
- 19 Federated States of Micronesia shall provide for fair State representation
- 20 on both the Board of Directors and the Credit Committee of the FSM Develop-
- 21 ment Bank."; and
- 22 WHEREAS, this Congress finds the resolution of the State-National

1 Leaders Conference to be eminently sensible and conducive to administra-
2 tion of the Economic Development Loan Fund in an impartial and sensitive
3 manner; now, therefore,
        BE IT RESOLVED by the First Congress of the Federated States of
5 Micronesia, Second Regular Session, 1979, that this Congress hereby
6 endorses the resolution of the State-National Leaders Conference of the
 7 Pederated States of Micronesia, requesting fair State representation on the
   Board of Directors and Loan Credit Committee of the Federated States Develop-
   ment Bank; and
        BE IT FURTHER RESOLVED that certified copies of this resolution be

   Micronesia, and to the members of the Board of Directors of the Federated
