A BILL FOR AN ACT

To renumber section 211, and to insert a new section 211B, of title 27 of the Code of the Federated Stats of Micronesia (Annotated), to require the Federated states of Micronesia Petroleum Corporation to create and execute strategic plans to transition into an energy company, to expand its business activities into renewable sources of energy, and to provide for changing the Corporation's name to reflect its expanded business activities, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 211 of title 27 of the Code of the
Federated States of Micronesia (Annotated), is hereby renumber to
read as follows:
"Section [211] 211A. Establishment of Corporation.

5 The Federated States of Micronesia Petroleum 6 Corporation is hereby established as a public 7 corporation under the laws of the Federated States of 8 Micronesia. It may hereinafter be referred to as 9 "The Corporation".

10 Section 2. Title 27 of the Code of the Federated States of 11 Micronesia (Annotated), is hereby amended by inserting new section 12 211B, to read as follows:

13	"Section 211B. Transition to an energy company with
14	focus on renewable energy sources. Notwithstanding
15	section 211A, 241, 242 and 243 of this chapter, the
16	Corporation shall Create and Execute five and ten year
17	strategic plans to expand its business into other energy

1	sectors and to enter into agreements with public
2	utilities and other energy distributors to provide
3	energy solutions to areas of the FSM that are un-served
4	or underserved. In recognition of the Government's
5	commitment made during the 23 rd annual Conference of the
6	Parties to the 1992 United Nations Framework Convention
7	on Climate Change in Bonn, Germany (COP 23) to increase
8	use of alternative energy sources, and in an effort to
9	gain accreditation for grant funding, the Corporation's
10	strategic plans shall prioritize the use and expansion
11	of renewable energy sources. In order to reflect the
12	business strategy of the Corporation and the policy
13	goals of the Government, once renewable energy comprises
14	at least 25% of the Corporations business activities the
15	Corporation shall make a report to Congress so that the
16	legal name of the Corporation may be change to reflect
17	the expanded business activities of the Corporation."
18	Section 3. This act shall become law upon approval by the
19	President of the Federated States of Micronesia or upon its
20	becoming law without such approval.
