## A BILL FOR AN ACT

To further amend chapter 6 of title 55 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Law Nos. 18-39, 19-39, and 19-46, to insert new sections 607A to establish an annual reporting requirement for the Imprest Revolving Funds, 612A to establish an annual reporting requirement for the Disaster Relief Fund, 629A to establish an annual reporting requirement for the Bond Repayment Fund, 682A to establish an annual reporting requirement for the Maritime Surveillance Revolving Fund, and 1612A to establish an annual reporting requirement for the Immigration, Customs and Quarantine Overtime Revolving Fund, and for other purposes.
