## A BILL FOR AN ACT

To appropriate the sum of \$7,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2019, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$7,000,000, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending
- 4 September 30, 2019, for the purpose of funding public projects and
- 5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk

21	funds, or so much thereof as may be necessary, are used solely for
22	the purpose specified in this act, and that no obligations are
23	incurred in excess of the sum appropriated. The allottee of the
24	funds appropriated under section 2 of this act shall be the
25	Governor of Yap State or his designee. The allottee of funds
