A BILL FOR AN ACT

To appropriate the sum of \$4,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$4,200,000, or so much thereof as
- 2 may be necessary, is hereby appropriated from the General Fund
- 3 of the Federated States of Micronesia for the fiscal year
- 4 ending September 30, 2017, for the purpose of funding public
- 5 projects and social programs for the people of Yap, Kosrae,
- 6 Pohnpei and Chuuk States. The fund shall be apportioned as
- 7 follows:

The allottee of funds appropriated under subsections 5(1), 5(3) and 5(6) of this act shall be the Governor of Chuuk State or his designee. allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands Development Authority. allottee of funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority. The allottee of funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The authority 11 of the allottee to obligate funds appropriated by this act 12 13 shall lapse on September 30, 2019. 14 Section 7.
