PUBLIC LAW NO. 20-62

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49 and 20-55, by amending section 1 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 18-11, as amended 1 by Public Laws Nos. 18-44, 19-128, 19-134, 20-11, 20-49 and 2 20-55, is hereby further amended, to read as follows: 3 "Section 1. The sum of \$1,680,000, or so much thereof 4 5 as may be necessary, is hereby appropriated from the 6 General Fund of the Federated States of Micronesia for 7 the fiscal year ending September 30, 2013, for the purpose of funding public projects and social programs 8 in the states of Pohnpei and Yap. The funds shall be 9 10 apportioned as follows:

(1) Pohnpei State.....\$ 1,130,000
PROVIDED, HOWEVER, that the funds appropriated in
subsections (b)(c)(d) and (e) of this section shall
not be allotted until Congress is officially advised
that funds improperly disbursed as a result of the
line item veto which was reflected in Public Law No.
18-11 are collected.
