## AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120, 19-137 and 20-29, by amending sections 1 and 2 thereof, to change the use, allottee and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, to correct technical errors, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 19-64, as amended
2	by Public Laws Nos. 19-81, 19-97, 19-120, 19-137 and 20-29, is
3	hereby further amended to read as follows:
4	"Section 1. Purpose. The sum of \$3,050,000, or so much
5	thereof as may be necessary, is hereby appropriated from
6	the General Fund of the Federated States of Micronesia
7	for the fiscal year ending September 30, 2016, for the
8	purpose of funding public projects and social programs
9	in the states of Kosrae and Pohnpei. The funds
10	appropriated under this section shall be apportioned as

25	Section 2. Section 2 of Public Law No. 19-64, as amer	nded

by Public Laws Nos. 19-81 and 19-97, is hereby further amended 1 2 to read as follows: 3 "Section 2. Allotment and management of funds and 4 lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for 5 6 in accordance with applicable laws, including, but 7 not limited to, the Financial Management Act of 1979. 8 The allottee shall be responsible for ensuring that 9 these funds, or so much thereof as may be necessary, 10 are used solely for the purpose specified in this act, and that no obligations are incurred in excess 11 12 of the sum appropriated. The allottee of the funds 13 appropriated under section 1 of this act shall be the President of the Federated States of Micronesia or 14 15 his designee; PROVIDED THAT, the funds appropriated under subsections 1(d) shall be the Mayor of Lelu 16 17 Town Government or his designee; the allottee of 18 funds appropriated under subsections 1(2)(1)(a)-(o), 19 1(2)(2)(a), 1(2)(2)(c), 1(2)(3)(a), 1(2)(3)(b), 20 1(2)(3)(d), 1(2)(3)(f) - (j), 1(2)(3)(1), 1(2)(3)(n), 21 1(2)(3)(q), 1(2)(4)(a)-(j) shall be the Pohnpei 22 Transportation Authority (PTA); the allottee of funds 23 appropriated under subsections 1(2)(2)(b), 24 1(2)(2)(d), 1(2)(2)(e) and 1(2)(2)(f) shall be the 25 Secretary of the Department of Transportation,

1	Communication and Infrastructure or his designee; the
2	allottee of funds appropriated under subsections
3	1(2)(2)(g), $1(2)(2)(h)$ , $1(2)(2)(1)$ and $1(2)(3)(m)$
4	shall be the Pohnpei Utility Corporation; the
5	allottee of funds appropriated under subsection
6	1(2)(2)(m) shall be the Secretary of the Department
7	of Education or his designee; the allottee of fund
8	appropriated under subsections $1(2)(4)(k)-(s)$ shall
9	be the Governor of the State of Pohnpei. The
10	authority of the allottee to obligate funds
11	appropriated by this act shall lapse on September 30,
12	2019."
13	Section 3. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its
15	becoming law without such approval.
