A RESOLUTION

Approving and accepting a grant in the amount of \$151,750 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to fund and support the FSM Linking Actions for Unmet Needs in Children's Health (LAUNCH) Project for the budget period from September 30, 2017, to September 29, 2018, including all the terms and conditions of the assistance.

1       WHEREAS, the United States through the Department of Health  
2 and Human Services, Substance Abuse and Mental Health Services  
3 Administration, issued a Notice of Award of financial assistance  
4 to the Government of the Federated States of Micronesia on July  
5 14, 2017, in the amount of \$151,750; and

6       WHEREAS, the purpose of the grant is to fund and support the  
7 FSM Department of Health and Social Affairs (LAUNCH) Project which  
8 aims at developing systems of early childhood care to promote  
9 healthy child development and positive mental health status  
10 nationwide; and

11       WHEREAS, section 210 (2) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended, provides  
13 that for an agreement on foreign financial assistance to be valid  
14 it must be approved by Congress by resolution; now, therefore,

15       BE IT RESOLVED by the Twentieth Congress of the Federated  
16 States of Micronesia, Second Regular Session, 2017, that Congress  
17 hereby approves and accepts the \$151,750 grant from the U.S.  
18 Department of Health and Human Services, Substance Abuse and


1 Mental Health Services Administration, to fund the LAUNCH Project  
2 in the FSM, including all the terms and conditions thereof; and  
3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated States  
5 of Micronesia, the Secretary of the Department of Health and  
6 Social Affairs, and the United States Embassy in Kolonia.
