## A RESOLUTION

Approving and accepting a grant in the amount of \$665,810 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Service Administration, to provide funding for prevention and treatment services related to substance abuse for the budget period from October 01, 2016, to September 30, 2018, including all the terms and conditions of the assistance.

- 1 WHEREAS, the United States through the Department of Health
- 2 and Human Services, Substance Abuse and Mental Health Service
- 3 Administration, issued a Notice of Award of financial assistance
- 4 on August 31, 2017, in the amount of \$665,810; and
- 5 WHEREAS, the purpose of the grant is to provide awareness of
- 6 the consequences of alcohol, tobacco, and other substance abuse,
- 7 and to provide treatment and recovery services to individuals
- 8 suffering from substance abuse; and
- 9 WHEREAS, section 210(2) of title 55 of the Code of the
- 10 Federated States of Micronesia (Annotated), as amended, provides
- 11 that for an agreement on foreign financial assistance to be valid
- 12 it must be a approved by Congress by resolution; now, therefore,
- BE IT RESOLVED by the Twentieth Congress of the Federated
- 14 States of Micronesia, Second Regular Session, 2017, that Congress
- 15 hereby approves and accepts the \$665,810 grant from the U.S.
- 16 Department of Health and Human Services, Substance Abuse and
- 17 Mental Health Service Administration, to fund for prevention and
