FOURTH SPECIAL SESSION, 2018 CONGRESSIONAL RESOLUTION NO. 20-106, C.D.1

A RESOLUTION

Calling on the President of the Federated States of Micronesia to support the membership of Vietnam on the United Nations Security Council as a non-permanent member for the 2020-2021 tenure.

1 WHEREAS, Vietnam desires to become a non-permanent member of
2 the Security Council of the United Nations for the 2020-2021
3 tenure; and

4 WHEREAS, Vietnam's candidacy has been endorsed by the Asia-
5 Pacific Group at the United Nations; and

6 WHEREAS, the Federated States of Micronesia (the "FSM") has
7 previously supported Vietnam's tenure as a non-permanent member of
8 the Security Council for 2008-2009; and

9 WHEREAS, Vietnam performed well on the Security Council in
10 2008-2009, dealing with complicated and sensitive issues within
11 the Security Council; and

12 WHEREAS, Vietnam has since then much increased its
13 international profile, and hosted successfully a number of
14 international meetings, including IPU in 2015, APEC in 2017 and
15 APPF in 2018; and


16 WHEREAS, the cooperation of the FSM and Vietnam has been
17 increasing; and

18 WHEREAS, the FSM Congress as Chair in 2018 of the Asia-
19 Pacific Group of the IPU is mindful of the feelings of its
20 regional group; now, therefore,

1 BE IT RESOLVED by the Twentieth Congress of the Federated
2 States of Micronesia, Seventh Special Session, 2019, that Congress
3 urges the President of the Federated States of Micronesia, if not
4 inconsistent with national policy, to endorse and support the
5 membership of Vietnam on the United Nations Security Council as a
6 non-permanent member for the 2020-2021 tenure; and


7 BE IT FURTHER RESOLVED that certified copies of this
