A RESOLUTION

Extending the National Declaration of Emergency for the Federated States of Micronesia for sixty more days.

1        WHEREAS, on February 22, 2019, the President of the Federated  
2 States of Micronesia had declared a National Declaration of  
3 Emergency for the Federated States of Micronesia because of  
4 Tropical Storm Wutip; and

5        WHEREAS, subject to consultation with Congress, within thirty  
6 days after the Declaration of Emergency, the Congress of the  
7 Federated States of Micronesia shall convene at the call of its  
8 presiding officer or the President to consider revocation,  
9 amendment, or extension of the declaration; and

10       WHEREAS, the Congress of the Federated States of Micronesia  
11 convened for its Seventh Special Session on March 8, 2019, for ten  
12 days; now, therefore,

13       BE IT RESOLVED by the Twentieth Congress of the Federated  
14 States of Micronesia, Seventh Special Session, 2019, that Congress  
15 hereby extends the National Declaration of Emergency for sixty  
16 more days; and

17       BE IT FURTHER RESOLVED that Congress recognizes that,  
18 pursuant to the President's authority under a declaration of  
19 emergency, the President of the Federated States of Micronesia may  
20 decree for this emergency any funds or foreign financial  
21 assistance, previously appropriated or approved and accepted by



1 resolution, that were designated for disaster relief, including,  
2 but not limited to, funds appropriated for Typhoon Maysak Relief  
3 under Public Law No. 18-115 and foreign financial assistance  
4 approved and accepted for emergency humanitarian assistance under  
5 Congressional Resolution No. 19-259; and

6 BE IT FURTHER RESOLVED that certified copies of this  
7 resolution be transmitted to the President of the Federated States  
8 of Micronesia, the Governor each state of the Nation, the  
9 Secretary of the Department of Foreign Affairs and the Secretary  
10 of the Department of Justice.




